Services Provided

- **Comprehensive Neurobehavioral Assessment and Diagnosis**

VIRTUAL appointments with our provider, including a thorough review of birth, developmental, medical, academic, family history, and areas of concern. **Comprehensive behavior rating scales** for parent, teacher, and self to evaluate for a broad range of behavioral, emotional, social, and academic issues. Follow up VIRTUAL appointment(s) to review results of all evaluations and provide diagnosis, personalized recommendations, and referral if needed. The child should be available for the initial intake appointment.

- **Autism Spectrum Disorder Assessment (ADOS-2)**

If there's a concern about autism, we offer the **ADOS-2-the gold standard, research-backed assessment** for autism spectrum disorder. This tool is completed alongside our initial neurobehavioral assessment to provide a thorough and accurate understanding of your child's unique strengths and needs.

The ADOS-2 can also be administered as a stand-alone evaluation. We would provide the result to you or your child's provider who can use it to supplement any existing assessments. The ADOS-2 is an **ON-SITE assessment** in our private, sensory friendly space designed to help your child feel comfortable and at ease.

- **IQ and Academic Achievement Screening (Ages 6 and Up)**

If there's a concern about learning difficulties, our screening provides valuable insights into your child's cognitive strengths and academic skill levels. This tool is completed alongside our initial neurobehavioral assessment-seamlessly integrated with our full evaluation.

The screening can also be administered as a stand-alone evaluation. We would provide the result to you or your child's provider who can use it to supplement any existing assessments. This is an **ON-SITE assessment** in a private sensory friendly space designed to help your child feel comfortable and at ease.

Conditions Within Scope:

- Attention-Deficit/Hyperactivity Disorder (ADHD)
- Oppositional Defiant Disorder (ODD)
- Conduct Disorder
- Anxiety Disorders (including Generalized Anxiety Disorder, Social Anxiety Disorder, Separation Anxiety Disorder)
- Depressive Disorders (mild to moderate Major Depressive Disorder, Persistent Depressive Disorder)
- Autism Spectrum Disorder (assessment, diagnosis, and coordination of care)
- Learning Disorders (screening and referral coordination)
- Simple Tic Disorders
- Other common pediatric developmental and behavioral conditions

Patients will be referred to appropriate specialists for conditions outside the defined scope of practice, including but not limited to:

- Severe depression
- Bipolar disorder
- Psychotic disorders (schizophrenia, schizoaffective disorder)
- Severe anxiety disorders requiring intensive treatment.
- Eating disorders
- Substance use disorders requiring specialized treatment.
- Self-harm or suicidal ideation requiring intensive intervention.
- Complex trauma or PTSD requiring specialized therapy.
- Severe behavioral disorders not responsive to initial interventions
- Any condition requiring inpatient psychiatric hospitalization.
- Medical conditions requiring subspecialty evaluation.

Referrals may be made to child and adolescent psychiatrists, developmental-behavioral pediatricians, clinical psychologists, or other appropriate specialists.
